# WESLEY QUARTER AND TRINITY ARCADE SHOP WESLEY + SHOP TRINITY CAMPAIGN: TERMS & CONDITIONS

# **Background to Promotion**

- 1. Wesley Quarter precinct, located at Wesley Quarter, 93 William Street, bounded by Hay, William & Murray Streets, Perth, WA, 6000 (**Wesley Quarter**), is managed by Lease Equity Pty Ltd, owned by Uniting Church in Australia Property Trust (WA) ABN 93 351 192 498 (**The Uniting Church in the City**).
- Trinity Arcade precinct, located at Trinity Arcade, 72 St Georges Terrace, 671 Hay Street, Perth, WA 6000 (Trinity Arcade), is managed by Lease Equity Pty Ltd, owned by Uniting Church in Australia Property Trust (WA) ABN 93 351 192 498 (The Uniting Church in the City).
- 3. Assembly & Co Pty Ltd (ABN 28 609 745 244) (**Promotor**) is the promoter of the Shop Wesley + Shop Trinity Promotion (**Promotion**), which comprises of:

- 22. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, Lease Equity Pty Ltd, and/or the Uniting Church, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter, Lease Equity Pty Ltd, and/or the Uniting Church reserve the right, in their sole discretion, to the fullest extent permitted by law:
  - a. to disqualify any participant; or
  - b. subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the Promotion, as appropriate.
- 23. In addition to clauses 22 and 23, the Promoter, Lease Equity Pty Ltd, and/or the Uniting Church reserve the right to cancel, terminate, modify or suspend the Promotion at their discretion.
- 24. The Promoter, Lease Equity Pty Ltd, and/or the Uniting Church reserve the right, in their sole discretion, to disqualify any individual who the Promoter, Lease Equity Pty Ltd, and/or the Uniting Church have reason to believe has breached any of these terms and conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Promotion. Errors and omissions may be accepted at the Promoter's discretion.
- 25. Failure by the Promotor, Lease Equity Pty Ltd, and/or the Uniting Church to enforce any of its rights under these terms and conditions does not constitute a waiver of those rights.
- 26. To the extent permitted by law, neither Lease Equity Pty Ltd, and/or the Uniting Church nor the Promotor are liable to Eligible Entrants for any direct, indirect, consequential, exemplary or incidental loss or damages or special or punitive damages arising out of or in connection with the entrant's participation in the Promotion even if Lease Equity Pty Ltd, and/or the Uniting Church or the Promotor have been advised of the possibility of such loss or damages.
- 27. Without limiting clause 26, neither Lease Equity Pty Ltd, and/or the Uniting Church nor the Promotor are liable for:
  - any entry or claim for prizes that is incomplete, incorrectly submitted, late, lost, stolen, altered, damaged or misdirected (whether or not after their receipt by the Promotor) including because of any failure in telecommunications equipment or service;
  - b. any financial, legal or tax liability that may arise from participation in the Promotion;
  - c. any defect or technical problem associated with the Redeemable Gift Cards or other Prizes.
